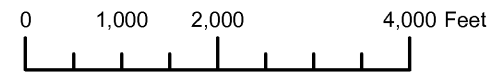

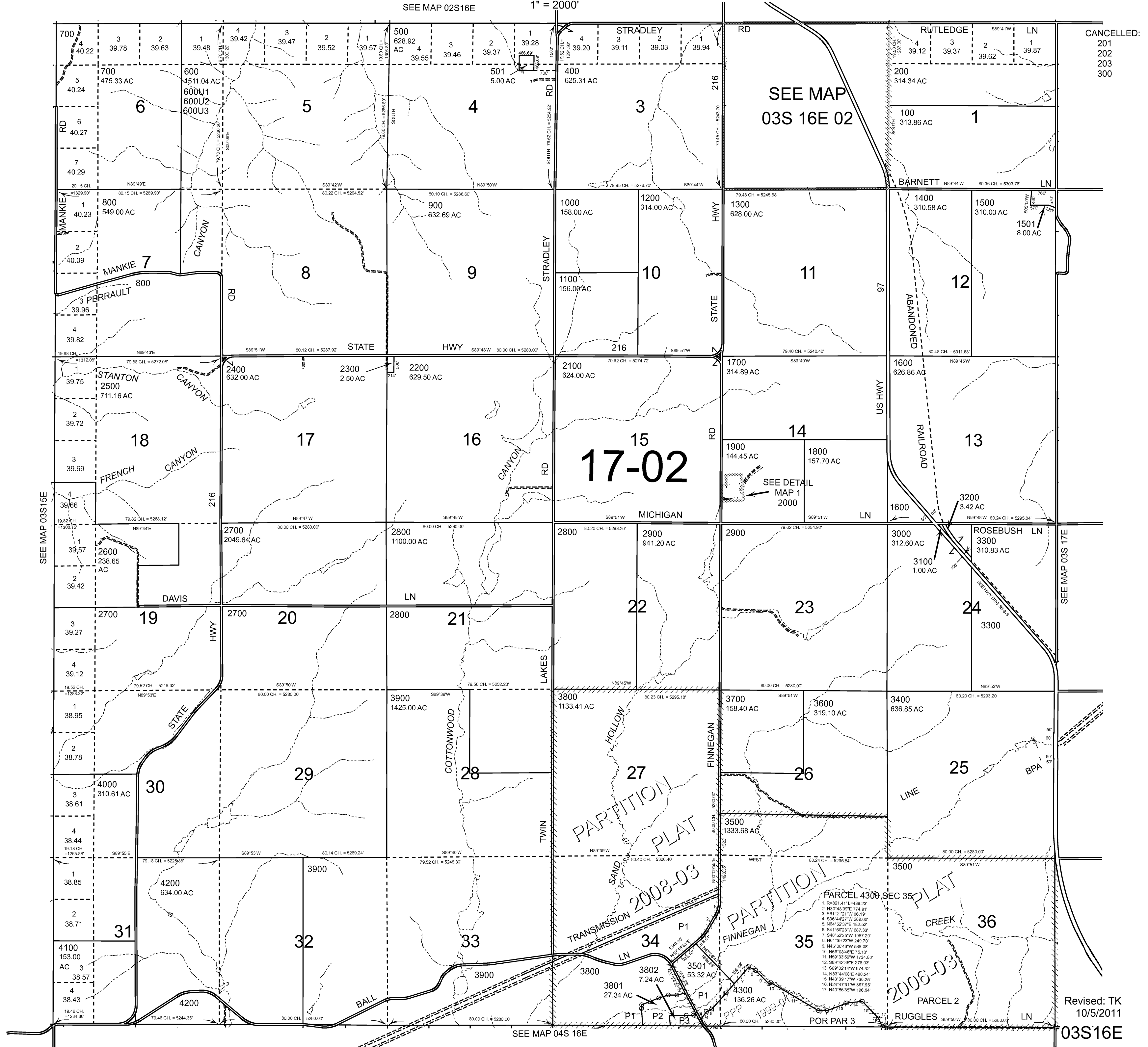


T.3S. R.16E. W.M. SHERMAN COUNTY
